("Purchaser") hereby agrees to purchase from the Fort Smith Classic the following Sponsor Package for the June 14 – June 20, 2010 Tournament:

Purchaser will receive the benefits listed on the appropriate Sponsor Package sheet, including all tickets and other features specific to the package selected.

It is understood that the Fort Smith Classic, a PGA TOUR golf tournament, is subject to schedule delays, changes or cancellations due to weather conditions and that, in such an event, refunds may not occur. The Purchaser also expressly recognizes and agrees that the Fort Smith Charity Classic, Inc. is responsible to the PGA/NATIONWIDE TOUR staff and players for the proper conduct of spectators and guests, vendors and tournament volunteers. Therefore, Fort Smith Charity Classic, Inc. reserves the right to refuse or revoke the admittance of any person to the tournament, who acts in a disorderly or disruptive manner as determined by the Fort Smith Classic. officials, and/or may refuse or revoke the use of any other privileges contained in the Sponsor Package because of such conduct. In such event, the Purchaser shall not be entitled to any refunds or return of any monies paid for the Sponsor Package.

The Purchaser also recognizes and expressly agrees that the Sponsor Package shall not be conveyed, assigned, sold or otherwise transferred for financial consideration to another person or entity without the written consent of the Fort Smith Classic. In the event of such transfer without prior written consent, the Fort Smith Classic shall have the right to refuse or revoke the use of any badges, tickets or other privileges provided in the Sponsor Package and shall not be required to refund or return any monies paid by the Purchaser for the Sponsor Package.

The Purchaser agrees that persons who use the badges, tickets and/or privileges contained in the Sponsor Package assume the risk of personal injury or property damage resulting from being hit by a golf ball or golf club or because of other hazards reasonably associated with attendance at a golf tournament. The Purchaser further agrees to indemnify and hold the Fort Smith Classic. and PGA TOUR, INC. participating players and all agents thereof harmless of any claims or lawsuits brought against such persons and/or entities and their employees and agents for such personal injury or property damage.

Purchaser acknowledges and agrees that the Fort Smith Classic's obligation under this agreement could be made impossible to perform if the golf tournament is cancelled, postponed or delayed as a result of weather, an act of God, fire or any other circumstance beyond the control of the Fort Smith Classic. In the case such an event occurs the Purchaser acknowledges that the Fort Smith Classic. is not obligated to refund amounts paid by Purchaser under this agreement.

This Agreement becomes valid upon the affixing of a signature to this document and the receipt of the amount set forth above. It is hereby understood by both parties to this Agreement that this contract shall entitle Purchaser to exclusive rights of Sponsorship for the Fort Smith Classic.
